



TERMS OF SALE



Minimum order value is \$100 net.

All Claims must be made within 2 days of receipt of shipment.

All Orders are subject to our approval and acceptance.

Possession of our catalog or price sheet does not constitute an offer to sell.

Prices may be subject to change and will be prices in effect at time of delivery.

Pricing is predicated on package quantities outlined in our catalog. A 15% broken package charge will apply on quantities that fall below that minimum.

Claims for lost or damaged shipments must be placed with the freight carrier.

Wal-Rich and it's divisions are not responsible for goods lost or damaged by the carrier.

Returned Goods Policy:

Regular stock items may be returned within 60 days of day of shipment, when accompanied by a return authorization. Credit for returned merchandise subject to examination and approval. A 15% restocking charge may apply.

Special order items must have a return authorization, and will be subject to a restocking charge.

Guarantee

Our goods are guaranteed to be free from manufacturing defects for a period of one year from date of purchase. We will replace any defective goods when returned to our factory prepaid, but will allow no claims for cartage, labor or consequential damages.

Backorders

We will hold all backorders except by customer request for cancellation. Backorders will be filled upon the receipt of backordered merchandise. Priority items should be communicated to our sales department for special handling. All open backorders will be cleared after four months from date of order.

Terms: 2% 10 Net 30 days. Discount applies to merchandise only, excluding freight charges. Invoices open after 60 days may be subject to interest charges. Outstanding credits may be used for merchandise only, and expire after 1 year. Cash discount does not apply to credit card payments.

Freight Allowance: All goods are F.O.B. Port Washington, New York. Consult freight chart below for prepaid, freight allowed (FFA) shipment requirements (standard, non-expedited service only). Certain product exclusions apply based on NMFC class. Call for more information.
